Our mission is to be a strategic advocate for our membership, to strengthen the economic vitality of our area, and to enhance the quality of life in our community.





Our businesses have taken countless steps to protect their employees, customers, and the public from day one of the COVID-19 pandemic. These new mitigations are arbitrarily targeting our restaurants and bars and will cause even more harm to an already-suffering industry while truly failing to slow the spread of COVID-19 in DeKalb County.

According to the DeKalb County Health Department, they currently cannot directly tie cases directly to our local bars and restaurants. Also, when asked specifically about the positivity rate, we were told that there is no data to show any positive outbreaks in DeKalb County restaurants and bars.
